OCTOBER 2022 PLUG POWER CONSTRUCTION UPDATE

The Town's engineer, Wendel completed 4 site visits in September and made the following observations;

- SWPPP inspections by the Plug Power engineer of record are taking place bi-weekly and the mailbox is in place that contains inspection reports.

- Fabrication of the interior stainless steel sphere is continuing by CB&I.
- Turf is establishing itself in all areas.
- Landscaping work is continuing. Involving topsoil, plantings in bio-retention area, and rip-rap replacement. Work is being completed by A-1 landscaping.
- Site Utility Plans Notice to Proceed expected in January of 2023.
- Plug Power will be working on the construction of building foundation packages once approved.
- Soil bores are underway for electrical switch gear.
- Substation work is expected to begin in late November 2022.
- Plug Power CM has additional support personnel at the field office, a Superintendent and Safety Officer are now on site. All visitors are required to sign in and complete a job site safety questionnaire.

Union Contract Memorandum of Understanding

MEMORANDUM OF UNDERSTANDING

WHEREAS, the Town of Alabama (hereinafter "Town") and the Teamsters Local 264 (hereinafter "Teamsters") entered into a Collective Bargaining Agreement which runs from January 1, 2021 through December 31, 2023, and

WHEREAS, the Town and Teamsters are in mutual agreement that certain adjustments to the current CBA are necessary for the purpose of attracting and retaining employees, and

WHEREAS, the Town and Teamsters agree that such circumstances are unique, now therefore:
IT IS HEREBY AGREED, BY AND BETWEEN THE PARTIES:

1. That the Wage Rates identified in Article 21 of the current CBA shall be adjusted to increase by \$1.00 per hour for 2023.

2. Accordingly, the Wage Rates identified in Article 21 of the current CBA shall be amended to read as follows:

21.1 Wage Rate: The hourly salaries for unit personnel shall be as follows:

2023 - \$27.76: MEO

2023 - \$28.26: MEO Lead Person

That this agreement is based on unique circumstances and nothing herein shall set a precedent for future situations.

3. That this agreement is prospective only, that it takes effect upon ratification by both parties, and that the wage rates changed in this agreement shall not be applied retroactively.

4. It is hereby expressly agreed and acknowledged that this agreement contains the entire understanding of the parties in that there are no additional promises, representations, terms, or provisions other than those contained herein.

5. That by their signatures below the signatories warrant that all necessary approvals and/or votes have been taken and that the signatories are authorized to bind the respective parties to this agreement.
